To the fullest extent permitted by law, Owner shall defend, indemnify and hold harmless Association and/or Contractor and/or Association Manager from and against all claims, damages, losses and expenses (including, without limitation, bodily injury and death) arising out of or resulting from Owner's presence on the San Carlos Condominium property during the duration of remediation and repair work at San Carlos Condominium, whether or not such claim, damage, loss or expenses was caused in whole or in part by said Association and/or Contractor and/or Association Manager.

Owner acknowledges that there are risks associated with accessing and occupying the properties that are undergoing storm damage reconstruction work.

Owner acknowledges these risks and voluntarily elects to be present with full knowledge of the risks of injury (including death), illness, or damage to property.

Owner waives all rights of subrogation, on behalf of themselves and their insurers, against the Association and/or Contractor and/or Association Manager for damage covered by insurance (before, during, or after completion of the work).
